
## ABOUT US REENTRY ROUNDTABLE

Restructured Reentry Roundtable governance and decision making process to ensure that systemimpacted leaders are guiding the direction of our coalition.


#### **CAPACITY BUILDING**

Gathered local reentry service providers to assess their interest in creating a Reentry Community of Practice to share best practices and increase knowledge of local reentry services.

## LEADERSHIP & CAREER DEVELOPMENT

Learned from local leaders in the reentry advocacy and leadership training community and developed a case statement for a reentry-specific leadership cohort program.

We used these findings to launch a leadership and professional development fund for Reentry Roundtable community members who are directly system-impacted.






